The rationale for this request was as follows:

- All apprenticeship management responsibilities are being transferred to NCI from Financial Services Ireland (IBEC) in October 2022.
- In 2021, HEA reduced the level of funding for the Higher Diploma in Financial Services Analytics which has had an impact of the future of the programme as it currently stands.
- The Higher Certificate in International Financial Services experienced low recruitment numbers and was not anticipated to go forward for revalidation. However, due to CSG and employers, strong support recruitment figures have increased for 2022. Therefore, an extension would facilitate extensive consultation with employers in determining a new programme offering to increase employer participation and apprenticeship numbers going forward.
- Over the past two years COVID-19 had an impact on the recruitment of apprenticeships for these programmes. In 2022, with the removal of restrictions and normalising of society, employers in the sector have more confidence and security in their staffing requirements, which allows for more active participation on these programmes.
- In June 2022, a report 'Financial Services in Ireland – Skills of the Future' was published. NCI would like to consider the report's findings and if changes are required to their existing apprenticeship programmes.

The Committee APPROVED the request to extend the last intake date of the programmes above to September 2023.

### **11. CHANGE OF STATUS OF LEGACY HET AND FET PROVIDERS**

- A. voluntary decision by the providers not to reengage, **or**

All providers listed in the documentation have been met virtually by QQI and have had the opportunity to agree a wind-down process to ensure that any programme in process and/or certification in process has been completed.

The Committee APPROVED the withdrawal of approval of the providers' quality assurance and withdrawal of validation of the associated programmes. The executive will send a registered letter of notification to each provider.

### **12. REPORT FROM THE PROGRAMMES AND AWARDS OVERSIGHT COMMITTEE (PAOC)**

#### **12.1 Report from the Programmes and Awards Oversight Committee of 5 September 2022**

Three programmes were reviewed by the relevant state regulators part of the approval process for inclusion in a register of approved programmes.

The findings of the review were negative and, as a result, the named provider withdrew the programmes from the process with a view to having them modified and subsequently revalidated.

Following extensive discussions with QQI, the provider decided that the programmes should cease so that Protection for Enrolled Learners (PEL) arrangements could be invoked.

The Committee APPROVED the withdrawal of validation of the programmes.
