# The rationale for this request was as follows:

- DBS has begun the review and revalidation process for the MSc in Business Analytics suite, and MSc in Information and Library Management suites however due to various workload commitments with the production of the Institutional Self-Evaluation Report (ISER) for DBS's upcoming institutional review, they were unable to assure themselves of the quality of the documentation for this evaluation in time for the review and were requesting an extension to allow the sufficient time for the revalidation process.
- The extension for all other programmes listed above were requested on the basis of the
  capacity of the institution due to volumes of programmes due for review in the 2023/24
  academic year and the Institutional Review process, and to ensure that full due diligence can
  be carried out.

The Committee APPROVED the request to extend the last intake date of the programmes to August 2025.

# 6.2 Applications for Revalidation

# 6.2.1 National College of Ireland

The Committee NOTED the documentation circulated. The Committee APPROVED the revalidation of the following programme for five years, subject to any special conditions of validation, and all the conditions from the current validation policy listed in the proposed Certificate of Validation:

6.2.1.1 PG25774, Higher Certificate in International Financial Services, Level 6, Major Award, 120 Credits

#### 6.2.2 **SOLAS**

The Committee NOTED the documentation circulated. The Committee APPROVED the revalidation of the following programmes for five years, subject to any special conditions of validation, and all the conditions from the current validation policy listed in the proposed Certificate of Validation:

6.2.1.1 PG25802, Advanced Certificate in Craft - Farriery, Level 6, Major Award, 240 FET Credits PG25803, Advanced Certificate in Craft - Electronic Security Systems, Level 6, Major Award, 240 FET Credits (PAEC/A71/6.2.2.1) [For Approval] Apprenticeship

The Committee noted the following update:

In a recent meeting between QQI and the National Apprenticeship Office (NAO), it was agreed that a process to update Craft programme standards and assessments was a priority for the migration strategy. NAO agreed to provide direction and oversight to the process through a senior member of staff.

Meetings between QQI and Solas (December 2022 and Spring 2024) agreed on a process to rapidly address this issue.

Solas was directed to refresh, for each of 20 Crafts:

- Occupational Profile
- Programme learning outcomes (MIPLOs). Solas also to provide evidence of industry endorsement for MIPLOs.
- Assessment materials. Solas also to provide evidence of endorsement from experienced instructors
  / assessors for revised assessments.

QQI agreed to accept the applications for revalidation based on receipt of this material and to issue updated certificates of validation with new programme and award codes.

#### **Process Implementation**

Solas has prepared:

- a schedule (Appendix 1 attached) of 20 programmes which will go through this refresh process in 2024.
- a map (Appendix 2 attached) of the process to update the programme outcomes and assessment materials and to get stakeholder endorsement of same.

As per the schedule, a number of programmes will be submitted for revalidation at each PAEC meeting.

# 6.3 Request for Modification of Validated Programmes

# 6.3.1 Griffith College

The Committee NOTED the documentation circulated.

Given the current application rates, and anticipated increased demand for the programme, this request sought to increase the maximum intake number on the full-time programme from 60 to **90** per intake, starting with the September 2024 intake. To accommodate this increased intake, it was also requested to increase the lecturer ratio from 1:70 to 1:90 in each instance of delivery of the composite modules. This increased lecturer ratio is in line with the current staff: learner ratio applied within Griffith, and the college has demonstrated its ability to successfully deliver programmes of large class sizes, and to support the learners appropriately. The modification request is related to increasing the intake for the full-time delivery of the Master of Science programme and subsequential increasing staff: learner ratio. This does not affect the embedded programmes in this suite, or the part-time delivery mode.

6.3.1.1 PG24273, Master of Science in Digital Transformation (Life Science), Level 9, Major Award, 90 Credits

The Committee APPROVED the modifications to the programme as requested by Griffith College.

#### 6.3.2 Dublin Business School

The Committee NOTED the documentation circulated.

The modification request related to increasing the maximum number of learners per intake for the full-time mode of these programmes:

6.3.2.1 PG24237, Master of Business Administration, Level 9, Major Award, 90 Credits PG24326, Master of Science in Cybersecurity, Level 9, Major Award, 90 Credits PG24328, Master of Science in Financial Analytics, Level 9, Major Award, 90 Credits PG24665, Master of Science in Data Analytics, Level 9, Major Award, 90 Credits PG24664, MSc in Digital Marketing & Analytics, Level 9, Major Award, 90 Credits PG25001, Master of Science in Supply Chain Management, Level 9, Major Award, 90 Credits

The Committee APPROVED the modifications to the programmes as requested by DBS.

# 7.1 Update on the follow-up of conditions of validation

As part of its internal quality assurance procedures, the executive is required to follow up on any Conditions of Validation imposed by the Programmes and Awards Executive Committee.

# 7.1.1 **Dublin Business School (DBS)**

The Committee NOTED the documentation circulated.

At the April 2023 PAEC meeting, QQI validated, with one condition, the following transnational programmes from DBS and collaborative partners University of New York in Prague:

PG24864, Master of Science in Business Analytics, Level 9, Major Award, 90 Credits PG24866, Postgraduate Diploma in Science in Business Analytics, Level 9, Major Award, 60 Credits (Exit Award)

PG24867, Master of Science in Digital Marketing and Analytics, Level 9, Major Award, 90 Credits PG24868, Postgraduate Diploma in Science in Digital Marketing and Analytics, Level 9, Major Award, 60 Credits (Exit Award)

On 19 January 2024, DBS submitted a response to address this outstanding condition – evidence of authorisation from the Ministry of Education, Youth and Sports, of Czech Republic.

The Committee NOTED that the executive now considers the condition to be met and that no further follow-up is required.

# 7.2 Update on the follow-up of conditions of QA Approval

As part of its internal quality assurance procedures, the QA Approval unit is required to follow up on any "Conditions of QA Approval" imposed by the Programme and Awards Executive Committee (PAEC).

#### 7.2.1 Brothers of Charity Services Ireland

The Committee NOTED the documentation circulated.

At its meeting on 7 February 2024, the PAEC approved the QA procedures of Brothers of Charity Services Ireland with five Conditions of QA Approval.

On 27 February 2024, Brothers of Charity Services Ireland confirmed that it had addressed the five conditions. It outlined what actions have been taken by the provider in respect of these conditions.

The Committed NOTED that the executive is satisfied that the five conditions of QA Approval have been appropriately addressed by the provider and that no further follow-up is required.

# 7.2.2 Irish National Organisation of the Unemployed

The Committee NOTED the documentation circulated.

At its meeting on 7 February 2024, the PAEC approved the QA procedures of Irish National Organisation of the Unemployed with five Conditions of QA Approval

On 28 February 2024, Irish National Organisation of the Unemployed confirmed that it had addressed the five conditions and outlined what actions have been taken by the provider in respect of these conditions.

The Committed NOTED that the executive is satisfied that the five conditions of QA Approval have been appropriately addressed and that no further follow-up is required.

# 7.2.3 Longford Women's Link

The Committee NOTED the documentation circulated.

At its meeting on 22 September 2022, the PAEC approved the QA procedures of Longford Women's Link CLG with six Conditions of QA Approval.

At its meeting on 1 December 2022, the PAEC noted that the executive considered the conditions 1,3,4,5 and 6 to be met.

On 16 February 2024, Longford Women's Link CLG confirmed that it had addressed condition number 2 and outlined what actions have been taken by the provider in respect of this condition.

The Committed NOTED that the executive is satisfied that the condition of QA Approval has been appropriately addressed and that no further follow-up is required.

#### 7.2.4 Qualtec

The Committee NOTED the documentation circulated.

At its meeting on 9 February 2023, the PAEC approved the QA procedures of Qualtec with four Conditions of QA Approval. At its meeting on 9 February 2023, the PAEC noted that the Executive considered three of the conditions of QA approval to be met.

On 13 March 2024, Qualtec confirmed that it had addressed the one outstanding condition and outlined what actions have been taken by the provider in respect of this condition.

The Committee noted that the executive is satisfied that the condition has been appropriately addressed by Qualtec and that no further follow-up is required.

# 7.2.5 Ability West t/a St Joseph's Training Services

The Committee NOTED the documentation circulated.

At its meeting on 7 February 2024, the PAEC approved the QA procedures of St Joseph's Training Services with one Condition of QA Approval.

St. Joseph's Training Services confirmed that it had addressed the condition and outlined what actions have been taken by the provider in respect of the condition.

The Committee NOTED that the executive is satisfied that the condition has been appropriately addressed by St Joseph's Training Services and that no further follow-up is required.

#### 7.2.6 Youth Theatre Ireland

The Committee NOTED the documentation circulated.

At its meeting on 7 February 2024, the PAEC approved the QA procedures of Youth Theatre Ireland with one Condition of QA Approval.

On 23 February 2024, Youth Theatre Ireland confirmed that it had addressed the condition and outlined what actions have been taken by the provider in respect of the condition.

The Committee NOTED that the executive is satisfied that the condition has been appropriately addressed by the provider and that no further follow-up is required.

#### 7.2.7 **Dublin 8 Community Education Centre**

The Committee NOTED the documentation circulated.

At its meeting on 7 February 2024, the PAEC approved the QA procedures of Dublin 8 Community Education Centre with five Conditions of QA Approval.

On 27 February 2024, Dublin 8 Community Education Centre confirmed that it had addressed the five conditions. It outlined what actions have been taken by the provider in respect of these conditions.

The Committee NOTED that the executive is satisfied that the five conditions of QA Approval have been appropriately addressed by the provider and that no further follow-up is required.

# 13. WITHDRAWAL OF PROVIDER QA APPROVAL

# 13.1 Withdrawal of Provider QA Approval

The Committee NOTED the documentation circulated.

Killucan Area Services CLG requested to have QA Approval and Programme Validation withdrawn post the reengagement process.

The panel recommended QA approval through the reengagement process following the submission of revised documentation post mandatory changes. However, the provider did not submit a formal response, or a factual accuracy check. On 20 November 2023, the provider informed QQI that they would be discontinuing their adult education programme because of their inability to resource and meet the new standards for Early Learning and Care. On 31 January 2024, the provider confirmed by letter that the Board of Killucan Area Services CLG had decided not to continue with the QQI Reengagement process and that it would not be continuing with the QQI accredited adult education programmes at its centre.

The committee APPROVED the withdrawal of approval of Killucan Area Services CLG' quality assurance procedures and approved the withdrawal of validation of its programmes.

# 14. QA APPROVAL: PROCESS TO EXTEND APPROVED SCOPE OF PROVISION TO INCLUDE BLENDED AND / OR ONLINE PROGRAMMES

# 14.1 QA approval: Process to extend approved scope of provision to include blended and / or online programmes

The Committee NOTED the documentation circulated.

In October 2023, QQI published new statutory QA Guidelines for Providers of Blended and Fully

Online Programmes. Providers who wish to have their approved scope of provision extended to include into these modalities need to have their QA procedures approved by QQI. On 7 February 2024, a proposed process to evaluate providers' applications for such an extension of scope was approved by PAEC. The process outlined in the documentation requires that QQI would stipulate the extension possible for a provider i.e. how far the provider could go along the continuum from fully onsite to fully online transnational, and that this would be proposed by the executive for approval by PAEC.

This paper presented for PAEC approval a schedule of all the providers seeking extension of scope and an outline of the evaluation method to be used in each case.

The Committee considered and APPROVED the proposed schedule for providers seeking to extend their approved scope of provision into blended and / or fully online modalities.
